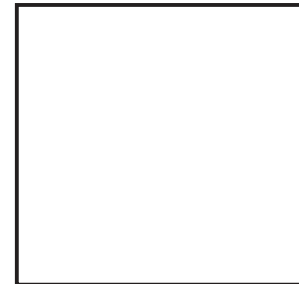

- Please note that only limited seats are allocated on each flight for rebated tickets, including the category 'Senior Citizen'. Hence confirmation of seats will purely be on first come first serve basis and no claims whatsoever will be entertained by Jet Airways in this regard.**
- At Present 50% concession is applicable on normal adult Economy Class Basic INR Fare for Indian nationals and 25% concession in USD for foreign nationals. Valid for travel on Jet Airways flights to Senior Citizens who have attained the age of 65 yrs on the date of travel.  
Discount is not applicable on IATT and PSF. However these are subject to change at the discretion of Jet Airways.

- Applicant shall pay a documentation process fee as may be determined by Jet Airways from time to time towards issue of Permanent Identity Card.
